TERMS AND CONDITIONS

To ensure equity, and fulfil our obligation to manage tax deductible bursaries appropriately, the following terms must apply to all Bursary applications.

Scholarship Bursaries (Fee Relief) are provided at the discretion of the School and subject to the School's ability to provide it. No guarantee is given as to the School's ability to provide scholarship bursary in future years. Bursaries (Fee Relief) are provided on the basis of the Business Manager's confidential assessment of your income and the family's ability to pay the scheduled School fees.

If a Bursary is made available, it is expected that, should there be a significant change in your family income (for whatever reason) you will notify the Business Manager. The School reserves the right to make adjustments to fees from the time of the change in circumstances.

In most instances, it will be sufficient to show the gross salary from your most recent Taxation returns (ie. income of both parents if both are in paid employment). However, this should be adjusted for any subsequent wage increases, promotions, changes in job, commencement or termination of employment, or any other cause.

Should it come to the attention of the Business Manager that family income disclosed for the purposes of this assessment is significantly understated, Fee Relief will be withdrawn and full fees charged, backdated to the commencement of the Fee Relief.
